Λ Application Must Have First Four Items Listed Below:

1. Application - Complete with notarized signatures of parents or guardian, if under 17 years of age. If parents are divorced, parent with custody must sign.
 2. State issued certified birth certificate. Hospital certificates are not acceptable.
 3. Social security card. Metal social security cards are not acceptable.
 4. Education form issued from your school of attendance. Valid for 30 days only!
- Λ If applicant is under 18 years of age and married, an education form is not required. Applicant must present a state issued certified marriage license.
- Λ No photostatic copies will be accepted on any documents.
- Λ Payments are made in cash, debit, or credit (no checks).
